Understanding Diverse Disabilities


One in five Americans have some form of disability or functional limitation. This does not include individuals who do not identify themselves as a person with a disability such as aging populations who have difficulty accepting their limitations or individuals from diverse ethnic and cultural backgrounds concerned about stereotypes and discrimination.

Disability may be physical, cognitive, sensory, emotional, developmental, or some combination of these. It is important to realize that not "one size fits all". Two people with the same disability may have significantly different needs that can be based on their age, history, culture, personality, access to resources, and support system. People with disabilities prefer to be seen for their abilities, not their disabilities. They are a person with a disability, not a "disabled person".

Not all disabilities are visible. A person may struggle to follow a conversation or respond, due to conditions like vision or hearing loss, or a brain injury. Avoid assumptions, stay open-minded, ask questions, and stay aware.

When and How to Assist Someone with a Disability

- **Respect**: Treat people with disabilities with the same respect as anyone else.
- **Assistance:** Always ask if help is wanted before offering assistance.
- Communication: Speak directly to the person, rephrase if needed, and include them in conversations.
- **Environment:** Be mindful of noise, accessibility issues, and physical barriers like steps or narrow doorways.
- Deaf/Hard of Hearing: Address the person directly, not the interpreter. Use all forms of communication, including speech, writing, and sign language.



Urgent: Provider Action Needed for Adult Long-Term Care Waiver Enrollment

The deadline for providers who deliver home and community-based services under one of Wisconsin's adult long-term care (LTC) waiver programs to enroll with Wisconsin Medicaid or to add adult LTC waiver services and programs to your existing Medicaid enrollment is **January 1, 2026**. This applies to:

- Adult LTC waiver-only providers.
- Medicaid-enrolled providers who also provide adult LTC waiver services.

ForwardHealth requires you to enroll with Wisconsin Medicaid as described in Wis. Admin. Code ch. DHS <u>105</u>. If you do not enroll, you cannot provide services or receive payment from managed care organizations (MCOs) or IRIS (Include, Respect, I Self-Direct) fiscal employer agents.

Safeguarding Personal Health Information

Member privacy is a top priority at Lakeland Care, Inc. (LCI). By ensuring member privacy, we foster member trust, increasing our ability to provide members with the superior care they deserve. As an LCI contracted provider, you also have a duty to protect member-protected health information (PHI).

Under the HIPAA Privacy Rule, Protected Health Information (PHI) is defined as "information, including demographic data, that relates to:

- the individual's past, present, or future physical or mental health or condition,
- the provision of health care to the individual or
- the past, present, or future payment for the provision of health care to the individual,

and that identifies the individual, or for which there is a reasonable basis to believe it can be used to identify the individual."

Common examples of PHI include names, dates of birth, addresses, phone numbers, email addresses, social security numbers, insurance ID numbers, health care records, and face photos.

HIPAA violations, in which PHI is inappropriately disclosed, erode member trust. Common privacy violations stem from lost devices, hacking, phishing, an employee accessing unnecessary information, improper disposal of documents, and releasing information after an authorization has expired.
